Middle School Enrollment Contract (Newly Enrolled Student)

By signing this Contract, I request that the School reserve a place for my child for the above-stated school year. Upon acceptance of the Enrollment Contract by Montessori Academy of Cincinnati, Inc., I understand that my obligation to pay the tuition and fees for the full academic year is unconditional and that no portion of fees paid or outstanding will be refunded or canceled in the event of absence, illness, failure to attend or withdrawal from the School of the above student.

Tuition Payments: Tuition for the above-stated school year is **\$10,570.00***. I understand that I am responsible for payment of the tuition for the entire school year and for other school-related charges that will be billed to me including, but not limited to, Field Trip and Activities Fees, any use of Before- and After-School Programs.

I understand that before acceptance by the School, I must submit the completed Application together with a non-refundable Application Fee in the amount of \$50.00. Within one calendar week of contact by the School regarding my child's acceptance, I will submit this completed Contract together with a Reservation Deposit in the amount of 10% of the annual tuition (\$1,057.00) to secure my child's space. Failure to meet this deadline could result in my forfeiting the space. This Deposit applies toward the tuition. Payment of the balance of the tuition is payable in one of the two following options (choose one option):

- Annual Payment. One payment in the amount of \$9,513.00 is due prior to August 1, 2011.
- Monthly Payments. Nine monthly payments of \$1,057.00 are due the first calendar day of each month (August through April). A \$30.00 Late Fee will be charged for any tuition payments received after the 4th of the month.

I understand that failure to make the initial tuition installment payment or any subsequent tuition installment payment by the date upon which it is due shall, at the sole discretion of the School, render the total amount of tuition remaining for the school year under this Contract immediately due and payable in full.

Policies: I understand that the School must comply with Regulations set forth by the State of Ohio, Department of Education. I understand that I must fully comply by completing all required forms with respect to these Laws and that the School reserves the right to exclude my child from its Programs if I do not do so. Such exclusion does not negate my financial obligations under this Enrollment Contract.

Withdrawal: As stated above, I understand that withdrawal of my child before the end of the school year does not relieve me of the obligation to pay tuition for the entire school year. However, I understand that should my child need to be withdrawn, assuming the procedures stated in the School Handbook are followed, the School will use its best efforts to mitigate my obligation for such tuition only after a new student is enrolled and fills the vacancy created by any such withdrawal.

Montessori Academy of Cincinnati shall have the right to legal action for collection of School tuition and fees and parents will be responsible for all costs of collection, including court expenses and reasonable attorney's fees.

Cancellation and Waiver: I understand that the School reserves the right to cancel this Contract if the school determines that my child should not continue as a student for any reason.

Agreement: The persons signing below agree to all the terms and financial obligations set forth in this Enrollment Contract and the accompanying Elementary Application.
